

## Swedish Institute Scholarship Programmes

### Swedish-Turkish Scholarship Programme and SI Scholarships for the Western Balkans 2020/2021

Thank you for applying for a Swedish Institute scholarship. We received **336** applications from 331 applicants. 236 of these candidates were admitted to a master programme: 18 from Albania, 13 from Bosnia and Herzegovina, 20 from Kosovo, 3 from Montenegro, 10 from North Macedonia, 8 from Serbia and 164 from Turkey. 20 are selected for a scholarship and 4 are placed on the reserve list.
